- 1. The Government of Liberia has received a grant from the **Liberia Reconstruction Trust Fund (LRTF) through the International Development Association (IDA)** toward the cost of the Cheesemanburg Landfill Urban Sanitation (CLUS) Project, and it intends to apply part of the proceeds of this grant to payments under the Contract for the Rehabilitation of the Transfer Stations and the Landfill with Lot 1 of the contract called "Rehabilitation of Fiamah Transfer Station", Lot 2 called "Rehabilitation of Stockton Creek Transfer Station", and Lot 3 called Installation of Solar Lights and Upgrading of Solar System.
- 2. The Monrovia City Corporation now invites sealed bids from eligible bidders for the Rehabilitation of the Two Transfer Stations. The work description includes:
 - > Construction of retaining walls around the waste storage areas;
 - > Clean and rehabilitate all leachate Manholes including the leachate collection tanks;
 - > Provide and install high-quality steel tops to cover leachate Manholes;
 - Removal of existing roofing sheets and damaged "I Beams";
 - ➤ Installation of new "I Beams" and replacement of existing roofing sheets with Aluminum long span'
 - Recondition administrative buildings by replacing damaged window glasses, retiling the floor, etc;
 - ➤ Provide materials and paint the entire structure including the retaining walls, "I Beams", steels trust, fence, and office buildings;
 - > Installation of solar lights within the two transfer stations and along the access roads;
 - > Upgrading of the solar systems at the two transfer stations.

The detailed work description is found in the bidding document.

The locations of the assignment are the Fiamah Community, Sinkor, and Stockton Creek Community, Japan Freeway. The work is required to last for three (3) months. No margin of preference is allowed.

3. Bidding will be conducted through the **National Competitive Bidding (NCB)** procedures specified in the World Bank Procurement Regulations for IPF Borrowers (Fifth Edition, November 2023), **and is open to all bidders from** Eligible Source countries, as defined in the Guidelines. In addition, please refer to paragraphs 3.14 and 3.15 setting forth the World Bank's policy on conflict of interest.

- 4. Interested eligible bidders may obtain further information from the Project Implementation Unit (PIU) of the Monrovia City Corporation, (Attention: Mr. Boye A. Robertson/Project Coordinator) and inspect the Bidding Documents at the address given below from 0900 hours to 1600 hours each working day.
- 5. Qualification requirements include:
 - a) Experience and past performance of the bidder on at least 2 (two) similar works done within the last five years (2018 2023), of similar nature and complexity;
 - b) Evidence of Access to Line of Credit of US\$ 100,000.00;
 - c) An average Annual turnover of US\$25,000.00 in each of the last five years, i.e. (2018 2023).
- 6. A complete set of Bidding Documents in ENGLISH may be purchased by interested bidders on the submission of a written Application to the address below at the offices of the Project Implementation Unit (PIU) for a non-refundable fee of US\$100.00 (One hundred United States Dollars). The method of payment will be by transfer/payment into the CLUS GOL SUPPORT Account Number: 00-1120-2584-703 held in SIB in Monrovia, and submitting the payment advice as evidence to collect the Bidding Document at PIU offices located within the premises of the Monrovia City Corporation (MCC Compound).
- 7. Bids must be delivered to the address below at or before 11:00 am GMT on May 1, 2024. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at the address below at the Conference Room of the Project Implementation Unit on May 1, 2024, at 11:10 am GMT.
- 8. All bids must be accompanied by a **Bid Security of US\$10,000.00** based on the format in the bidding document.
