The Government of Liberia through the Ministry of Agriculture has received grant from the Global Agriculture Food Security Program (GAFSP) of the World Bank Group and the African Development Fund (ADF) of the African Development Bank (AfDB) for Agriculture in Liberia. This grant will be used to finance activities of the Smallholder Agriculture Development for Food and Nutrition Security (SADFONS) Project. The project intends to apply part of the proceeds toward the supply of Lot #: 1 – Small Tools (Garden Kits) and Lot #: 2 – (Planting Materials).

- One (1) year warranty on all goods to be supplied for all the Lots;
- Past performance history in the supply of goods of similar nature with at least Three (3) references with names, address and contact numbers;
- Delivery is immediate meaning the availability of goods to be supplied;
- Bid validity Period (90) days;
- Access to a line of credit/Audited financial Statement for the last two/three
- (2 or 3) years;
- Form of Bid Security: Bank Guarantee obtain from a reputable Banking Institution. The Bid Security (Bank Guarantee) amount shall be as stated in the matrix above
